



ACCEPTABLE DESKTOP FILE FORMATS:

Business Report is created in Adobe InDesign CS2.

Camera Ready Ads: High resolution PDF format ONLY. Please use Adobe Acrobat Distiller "PRESS" default settings.

Scratch Ads Created at Business Report: Elements (original art, logos, etc.) created with Microsoft Publisher, Microsoft Word or Powerpoint will not be accepted. Most other programs are supported including InDesign, Photoshop, and Illustrator.

IMAGES/SCANS: All images/scans should be 300 dpi saved as a TIFF or an EPS. We cannot accept RGB colors or 72 dpi (i.e., images pulled from website).

All color images provided on disk must be CMYK format and color corrected. We are not responsible for color on RGB files that must be converted to CMYK. Please make sure process separation is checked for all process color builds. B&W scans should be saved as grayscale or bitmap.

ACCEPTED FONTS: PDF files with fonts embedded are preferred. All printer and screen fonts must be included with all live digital files. Please use stylized fonts and do not use menu-styled fonts for bold, italics or bold italic type. All fonts used in art files must be converted to outlines.

LOGOS AND ARTWORK: Images should be EPS files. Avoid rotation and cropping of images in layout program and do not nest EPS files in other EPS files. Supply InDesign "PreFlight" report or similar reports.
